SUBJECT: CHARGES RE: AI-16-021

An investigation has been conducted by the Administrative Investigation Division, Professional Standards Bureau, of the Pinellas County Sheriff's Office. As a result of this investigation, the Administrative Review Board has determined you committed the following violation:

On, but not limited to, September 7, 2016, while on duty in Pinellas County, Florida, you violated the Pinellas County Sheriff's Civil Service Act Laws of Florida, 89-404 as amended by Laws of Florida 08-285, Section 6, Subsection 4, by violating the provisions of law or the rules, regulations, and operating procedures of the Office of the Sheriff.

1. You violated Pinellas County Sheriff's Office General Order General Order 3-1.3, Rule and Regulation 3.31(g), Inappropriate Conduct by Members of the Agency.

Synopsis: On September 7, 2016, a Sergeant, under your command, engaged in a high speed pursuit, in violation of agency policy. You failed to terminate the pursuit which contradicted guidelines.

Specifically, at approximately 0140 hours, a vehicle fled from a traffic stop attempted by a deputy in the area of U.S. 19 and Republic Drive. The deputy advised via radio of criminal charges, which would not, by policy, authorize the initiation of a pursuit. Per guidelines, the deputy also advised that he was not in pursuit.

Within approximately 12 minutes, the sergeant under your supervision, located and began to actively pursue the vehicle, providing its location and status via radio. The unauthorized pursuit of this vehicle lasted 24 minutes and traveled 31.6 miles into the city of Tampa.

During the pursuit, video evidence confirmed multiple deputies, attempting to assist in the unauthorized incident, traveling at speeds of over 100 MPH, through intersections, with and without emergency equipment, lights and sirens, in multiple areas of the county. Although not actively engaged in the pursuit, you acknowledged traveling at speeds in excess of 100 MPH during the incident.

This pursuit did not involve a forcible felony, an enumerated crime, an imminent and/or continuous threat, or extremely dangerous driving as required by policy. You were the supervisor responsible for member's actions and acknowledged this during testimony, however you failed to terminate this unauthorized pursuit.

The Administrative Review Board determined you committed this violation.

Disciplinary Points and Recommended Discipline Range:

You were found to be in violation of one (1) Level Three Rule and Regulations violation totaling fifteen (15) points. At this point level, the recommended discipline range is from a reprimand to three (3) days suspension.

Disciplinary action shall be consistent with progressive discipline, for cause in accordance with the provisions of the Rinellas County Civil Service Act.
